

- 4. Scroll through the list to view the available Acts or Orders and related amendments. PrincipalActs or Orders will be listed in capital and bold letters in the first column. Immediately below then ame of the principal Act or Order, there will be listed related amendments to the principal ActorOrder. The second column shows the chapter number for Acts or the relevant Government Gazette number for Orders and Amendment Orders. The third column shows the commencement date. The fourth column shows the latest revised version of the principal Act or Order.

- 5. To <u>VIEW ACTS</u>, return to the <u>LEGISLATION ON-LINE</u> homepage in step 1. The Acts will be listed in accordance with the chapter number. Click on the name of the Act to view and/or download the Act.
- 6. To <u>VIEW ORDERS</u>, return to the <u>LEGISLATION ON-LINE</u> homepage in step 1. The Orders will be listed in alphabetical order. Click on the name of the Order to view and/or download the Act.
- To <u>VIEW AMENDMENTS</u>, make sure that you have noted the Government Gazette number. For example, for the Penal Code (Amendment) Order 2012, the Government Gazette number is S26/2012. 2012 is the publication year of the Gazette. 26 is the publication number of the Amendment Order within the relevant year's Gazette.

Click on the publication year and then search according to the publication number in the next page. Click on the name of the Amendment Order to view and/or download the Amendment Order.
